## SHAKE WELL BEFORE USE

While foliar biostimulants are extremely useful for turfgrass, MP KELPLUS is formulated specifically for soil use. MP VITALISE is the MATCHplay product for preconditioning turfgrass with foliar applied nutrition. While MP KELPLUS is safe to apply to turf foliage, it's powerful ingredients are most useful when washed lightly into the soil after application or alternatively mixed with irrigation water.

#### SOIL APPLICATION

When applied as a drench or when lightly watered into the turf root zone. MP KELPLUS supplies naturally derived plant hormones for increased root growth, thicker cell walls and increased antioxidants for better stress management. The combined benefits of MP KELPLUS help develop a turf sward that is more resistant to damaging turf pests such as nematodes, soil born insects and turf diseases.
