RESPONSE

GENERAL INFORMATION

SUPERMANZ is a flowable formulation of mancozeb. **SUPERMANZ** is a protectant fungicide. Complete coverage is essential.

RESISTANCE MANAGEMENT

SUPERMANZ contains a dithiocarbamate fungicide, Group M3. Disease control may be reduced if strains of pathogens less sensitive to mancozeb develop. Use **SUPERMANZ** in a spray program with fungicides with an alternative mode of action.

DIRECTIONS FOR USE

The rates expressed are high volume spraying to runoff. For concentrate spraying, adjust dilution rate accordingly.

FRUIT	FRUIT					
Grapes	Anthracnose (black spot), downy mildew, dead arm disease	350 mL/100 L	Apply at budburst and repeat at 10-14 day intervals			
Passionfruit	Brown spot, Septoria spot	350 mL/100 L	Apply in an alternating programme with copper sprays on a 14-21 day schedule.			
Peaches, nectarines	Rust	265 mL/100 L	Apply in early November and repeat 2 or 3 times at 14-21 day intervals. To avoid spray deposits on fruit, do not apply within 6 weeks of harvest.			
BERRY FRUIT						
Blackberries	Rust, cane spot, dryberry	265–350 mL/100 L	Apply at 10-14 day intervals from shoot development up to petal fall and again after harvest.			
Strawberries	Mycosphaerella leaf spot	350 mL/100 L	Apply in mid-June and repeat at 10-14 day intervals or closer in wet conditions.			
Other berryfruit	Leaf spot, rust, downy mildew (dryberry)	350 mL/100 L	Apply at greentip and repeat every 10-14 days.			
VEGETABLES						
Cabbage, celery	Downy mildew, Septoria leaf spot	265-350 mL/100 L 3.2-4.4 L/ha	Apply at 3-7day intervals in the seed bed and 7-10 day intervals in the field.			
Carrots, lettuce, beans	Cercospora leaf spot, downy mildew, rust, pleospora spot, anthracnose	265-350 mL/100 L 3.2-4.4 L/ha	Apply at first appearance of disease and repeat at 7-10 day intervals.			
Onions	Downy mildew	265-350 mL/ 100 L 3.2–4.4 L/ha	Apply when conditions favour infection and repeat at 7-10 day intervals.			
Potatoes	Late blight, early blight	2.6–3.5 L/ha	Apply every 7-10 days or more frequently under severe blight conditions. Increase the rate as plants increase in size.			
Pumpkin, melons, cucumbers, other cucurbits	Downy mildew, anthracnose	265-350 mL/100 L 3.2-4.4 L/ha	Apply at 5-7 day intervals.			

CROP	DISEASE	RATE	COMMENTS
Tomatoes	Early blight, late blight, leaf mould, anthracnose	265-350 mL/100 L 4.4 L/ha	Apply at 7-10 day intervals or more frequently under blight conditions.
ORNAMENTALS	Black spot, flower blight, rust, septoria leaf spot.	265-350 mL/100 L	Apply at 7-10 day intervals.

MIXING

Always shake the container before use. Pour the required amount into the partly filled spray tank with agitation running. Complete filling the tank. Maintain agitation until spraying is complete.

COMPATIBILITY

SUPERMANZ is compatible with most commonly used agrichemicals. Do not mix with lime sulphur or Bordeaux mixture.

WITHHOLDING PERIOD

Tomatoes, cucurbits – 1 day All other crops – 14 days
