### Section 4: FIRST AID MEASURES

**Description of First Aid measures:**

**General Advice:** For advice contact the National Poisons Centre on 0800 POISON (0800 764 766) or a doctor immediately. Begin artificial respiration if the victim is not breathing. Use mouth to nose rather than mouth to mouth. Obtain medical attention.

**If inhaled:** Move the victim to fresh air.

<b>Exposure controls</b>	
<b>Engineering measures:</b>	Containment and/or segregation is the most reliable technical protection measure if exposure cannot be eliminated.
