### Section 4: FIRST AID MEASURES

**Description of First Aid measures:**

**General Advice:**

### Exposure controls

#### Engineering measures:

Containment and/or segregation is the most reliable technical protection measure if exposure cannot be eliminated.  
The extent of these protection measures depends on the actual risks in use.

##### Remarks:

The choice of an appropriate glove does not only depend on its material but also on other quality features and is different from one producer to the other. Please observe the instructions regarding permeability and breakthrough time which are provided by the supplier of the gloves. Also take into consideration the specific local conditions under which the product is used, such as the danger of cuts, abrasion and the contact time. The breakthrough time depends amongst other things on the material, the thickness and the type of glove and therefore has to be measured for each case. Gloves should be discarded and replaced if there is any indication of degradation or chemical breakthrough.

#### Skin and body protection:

Assess the exposure and select chemical resistant clothing based on the potential for contact and the permeation / penetration characteristics of the clothing material.  
Wash with soap and water after removing protective clothing.  
Decontaminate clothing before re-use or use disposable equipment (suits, aprons, sleeves, boots, etc).
